

NARRATIVE

On 09/06/2023 I responded to 2006 Heritage Walk (Milton City Hall) in reference to a report.

Upon arrival, I met with the reporting party / victim Robert Jamison. He advised on 09/03/2023 at 09:47 P.M. he received two text messages from a telephone number he did not recognize. The text messages, which were supplied to me, read 1) "there's gonna be a change round here." and 2) "There's eyes on you n ur lil family." (the second text also included an emoji of a family) The text messages will be uploaded into RMS. Mr. Jamison was able to offer no further details.

On 09/07/2023 I was informed by CID Sgt. Lappin that the previous evening (09/06/2023) while working City Council Security he was informed that Mr. Jamison had received further threats. On that same date, I conducted a phone interview with Mr. Jamison, and he stated that on the previous evening, he was in a meeting at City Hall and received a call from another number that he did not recognize. He stated that at 05:29 PM he answered the call and could only hear muffled noises and thought he had a bad connection. Mr. Jamison stated he hung up the phone and did not return the call. He stated he received another call from the same unrecognized phone number minutes later and when he answered he heard muffled sounds but no understandable dialogue. Mr. Jamison stated "Hello, I can't hear you." Mr. Jamison then stated it sounded like the caller was using a voice modulator or disguiser while speaking. According to Mr. Jamison, the person on the phone stated, "I'm going to kill you." Mr. Jamison stated "Ok, can you repeat that?" The person on the phone again said, "I'm going to kill you." Mr. Jamison stated "Hold, on. maybe you could say that again to this person" and he gave the phone to Police Chief Rich Austin, who just happened to be at City Hall.

I spoke with Chief Austin who advised he was at City Hall when Mr. Jamison handed him his phone. Chief Austin stated he heard a voice he described as "whispering" on the phone. He introduced himself as "Chief Austin" He stated the person on the phone was murmuring numbers which sounded as though they were a reference to an address and the statement "I'm going to kill you." Chief Austin then asked "Who are you going to kill?" The caller replied, "I'm going to kill you and everyone there." and then the caller disconnected the phone.

Mr. Jaminson stated he then received three additional text messages at 5:34 PM from the same unrecognized phone number. Those text messages stated 1) "Leave now. And don't show up in any part of Milton exposed." 2) "Georgia is going down. Especially here." 3) "You fucked up.".

The Milton Criminal Investigations Division was given all the current details of the incident and will be conducting the investigation moving forward.
